IMPORTANT:

1. All horse owners **must attend the first Rodeo Club meeting of every month**. Attendance will be taken.
2. Due to limited space, a priority list will be established by the Rodeo Club/Equine Centre Coordinator. The coordinator has the right to designate and change penning/stalling throughout the year. Priority will be given to students competing on the Rodeo Team.
3. No stallions will be admitted.
4. At any time throughout the year, the Rodeo Club/Equine Centre Coordinator has the right to move or isolate any horse if the safety or health of that horse or a surrounding horse is jeopardized.
5. Any owner(s) of a horse that is showing signs of neglect or malnourishment will be asked to remove the horse from College property.
6. Horses **must** be accepted before arrival. **Not all** applications will be **accepted**.
7. Applications must be received by **June 30**. **Applying early will not** necessarily give you **priority**; however, applications received by the July 31 deadline will be considered before late applications. Applicants will be notified if they have a spot shortly after the deadline.
8. Any horse hurt or injured, or who dies on Lakeland College property is not the responsibility or a liability of Lakeland College or the Lakeland College Rodeo Club. The owner is responsible for any and all veterinary costs. The College does not carry livestock insurance on boarded horses. It is recommended for owners to carry their own personal livestock insurance on their horses.
9. **No individual penning is available**. All horses must be fed and cared for by their owner daily.
10. Refer to page 3 for health protocols. If your horse **comes to campus before October 20**, a **Coggins test** must be **submitted before** your horse **arrives**. Coggins test **will not be accepted** if they are **done before August 2**. If your horse arrives after October 20, a Coggins test is not required.
11. Rodeo club members and students with horses in the Rodeo pens are required to volunteer at rodeo events throughout the year.
12. Students are responsible for their own horses. If a student leaves their horse for others to care for, this is at their own risk and responsibility. The College will not be held responsible.

LAKELAND COLLEGE RODEO CLUB BARN RENTAL AGREEMENT

I, _____, agree to the following:

1. The Rodeo Club Barn is to be kept neat and clean. Failure to do your share of the clean-up will cause you to lose your stall.
2. **No** smoking or drinking allowed in the barns or Equine Centre. **No** drinking in the Equine Centre unless it is at a licensed function.
3. Manure is to be dumped in designated areas, **not in front of the doors!**
4. Keep all tack locked up to the best of your ability.
 - Tack boxes are only available for the 34 stalls in the Rodeo Barn
 - An extra tack box(es) may be available to you if all the stalls are not rented
5. Park horse trailers in designated areas.
6. Keep all alleys swept and clean at all times.
7. Put tools away after use. This includes, but is not limited to manure carts, forks, etc.
8. Keep tack rooms clean. Limited space for tack is available on a first come, first served basis in the tack shed for students who do not have a stall in the Rodeo Barn.
9. **Do not waste hay** as it is expensive. If hay is wasted, your rent will go up.
10. Stalls **must** be cleaned daily by 10 am. If stall is not kept clean, you will lose your stall privileges.
11. Being allowed in the Rodeo Club Barn is a **privilege**. This means regularly volunteering to help out. Failing to help the Rodeo Club when called upon can also cause you to forfeit your stall. Remember, a lot of students applied for your stall, so look after it!
12. Rent is to be paid at the **beginning of September and January**. You pay for the first semester in September and the second semester in January.

Boarding fees per horse are as follows:

- **Outdoor** pen with feed - **\$1100** per semester
- **Tie stall** - **\$1200** per semester
- **Box stall** - **\$1300** per semester
- **A turnout pen is included in all stall prices**

Once you commit to a spot, you are required to pay the full semester's boarding fee.

13. **You must pay for the full semester**. Even though you may take your horse off campus in December or early April, you must still pay for the full semester. There are exceptions:
 - If you are on campus for 2 months or less, you will pay a monthly rate of \$275
 - 2nd year Veterinary Technology students who have practicum will pay for 3 months in Semester 2 – if they are taking their horse out of the Rodeo Barn
14. **Failure to follow** any of the rules is **unacceptable**. If you have questions about any unclear rule, please ask the Rodeo Club/Equine Centre Coordinator.

LAKELAND COLLEGE HEALTH PROTOCOLS FOR HORSES BOARDING ON CAMPUS

1. No stallions will be admitted onto campus.
2. All horses are required to have a **Coggins** test between **August 2 and 30, 2025**. Proof of a **negative** Coggins test must be presented to the office of the Rodeo Club/Equine Centre Coordinator, **at least 24 hours before** the arrival of your horse on campus.
3. The following vaccinations must be current and required boosters given if necessary. Proof of purchase or a vaccine certificate from your veterinarian **must** be presented to the office of the Rodeo Club/Equine Centre Coordinator, **at least 24 hours prior** to the arrival of your horse on campus.
 - a) **Eastern and Western Encephalitis, and Tetanus - “3-way vaccine”**
Must be given within six months of arrival.
 - b) **Equine Influenza and Equine Rhinopneumonitis**
If the horse has not received this vaccine before, it will require two vaccinations – the first between **July 2 and 30**, with a booster vaccine **3 to 4 weeks after** initial vaccination.

If the horse has been given this vaccine within the past 12 months, they will require a single booster vaccine between **August 2 and 30**.

All horses will **require** revaccination for Equine Influenza/Rhino between **December 15, 2025 and January 15, 2026**.
 - c) **Strangles (intranasal vaccine)**
If the horse has not received this vaccine before, it will require two doses – the first dose should be given between **July 2 and 30**, with a booster vaccine to be given **3 to 4 weeks later**.

If the horse has been given this vaccine within the past 12 months, they will require a single booster **August 2 and 30**.

Please note: Strangles intranasal vaccine should **not** be given to horses that have had an active Strangles infection within the past 12 months.

It is not recommended to give the Strangles intranasal vaccine on the same day as any intramuscular vaccine. If unable to follow this recommendation, always give the **intramuscular** vaccine first.

In high-risk areas, a booster vaccine for Strangles is recommended at six-month intervals.
 - d) **West Nile Vaccine**
Recommended, but not required.
4. All horses must be dewormed after **August 15, 2025** and **before arrival** on campus. Proof of purchase is required upon arrival.
5. Students are responsible for maintaining adequate health care for their horse. This includes follow-up vaccinations, deworming, hoof care, dental care and any other necessary veterinary care as required. It is the student’s responsibility to arrange for health care for their horses from local veterinary clinics. **College staff veterinarians are not able to perform veterinary services on privately-owned horses.**
6. If your horse shows signs of infectious disease, such as:
 - Nasal discharge
 - Cough
 - Swelling under the jawYou are required to immediately notify the Rodeo Club/Equine Centre Coordinator. The horse may be isolated and restricted from participation in College events.
7. Lakeland College requires proof of a current vaccination status from your local veterinarian. We suggest when your horse is seen by your veterinarian for its Coggins test, that the vaccinations be administered at the same time. Intranasal vaccinations can be difficult to administer and some horse owners have trouble giving them correctly. Since the health of our entire herd of horses, as well as all horses competing at the intercollegiate rodeo level depends on everyone’s individual compliance, it is important that each horse has up-to-date vaccinations.

TO: Lakeland College, Lakeland College Rodeo Club and Lakeland College Conference Services, and their respective directors, officers, administrators, employees, servants, agents, subcontractors and independent contractors:

1(a) I am the full age of 18 years and wish to participate in rodeo activities, equine activities, livestock related activities and all other activities which are part of or which may be associated with any or all of the rodeo activities, equine activities and livestock related activities as carried-on, conducted or provided by either or both of Lakeland College or the Lakeland College Rodeo Club (all of which activities are hereinafter collectively called "Rodeo Activities"), under the direction of their respective directors, officers, administrators, employees, servants, agents, subcontractors, independent contractors and licensees (all of whom are hereinafter referred to collectively as "Lakeland").

1(b) I wish to have a minor person under the age of 18 years (hereinafter called the "Minor") participate in rodeo activities, equine activities, livestock related activities, and all other activities which are part of or which may be associated with any or all of the rodeo activities, equine activities and livestock related activities as carried-on, conducted or provided by either or both of Lakeland College or the Lakeland College Rodeo Club (which activities are hereinafter collectively called "Rodeo Activities"), under the direction of their respective directors, officers, administrators, employees, servants, agents, subcontractors, independent contractors and licensees (all of whom are hereinafter referred to collectively as "Lakeland"). To induce the acceptance and admission of the Minor for participation in the Rodeo Activities I represent and warrant that I am one of the parents of the Minor, or I am a duly appointed guardian for and on behalf of the Minor, and that I have full authority to act and to grant permission on behalf of the Minor in this matter.

ASSUMPTION OF RISKS:

I am aware that Rodeo Activities and all and any other activities which are either integral or incidental to Rodeo Activities, is dangerous, and is part of a violent, high-risk, physically dangerous sport, and that I am participating solely and absolutely at my own risk alone, and not in reliance upon any right to claim any loss or damages or indemnification from Lakeland for any damage or loss that I may suffer, or that I may cause to other individuals, persons or to property, as a consequence of my participation.

In the case in which I am authorizing and granting permission for the Minor to participate in Rodeo Activities and all or any other activities which are either integral or incidental to Rodeo Activities, such participation shall be at the Minor's own risk and at my own risk alone, as the sole and absolute indemnifiers against any loss or damage that may be suffered by the Minor, or that may be caused by the Minor to other individuals, persons or to property, and that any participation by the Minor in Rodeo Activities shall be permitted by Lakeland in reliance upon my absolute release and full indemnification of Lakeland from all lawsuits, liabilities or claims for any losses or damages or for indemnification by any individual or person which may arise from the Minor's participation in Rodeo Activities, and upon my full and absolute indemnification of the Minor for any damages or losses that the Minor may suffer, or that the Minor may cause to other individuals, persons or to property, and that such participation by the Minor shall be permitted to occur only upon my prior assumption of all risks relating to the participation of the Minor in Rodeo Activities and the grant of my undertaking of full indemnification as stated according to the terms of this document. I acknowledge that I have fully considered my consent and approval of the Minor's participation in Rodeo Activities, and that I am acting with full knowledge that Rodeo Activities is a violent, high-risk, physically dangerous sport, and I am acting with full knowledge of the inherent risks, liabilities, dangers, hazards and conditions of the sport of Rodeo Activities.

I further acknowledge the inherent risks, liabilities, dangers, hazards and conditions of Rodeo Activities include, but are not limited, to:

- i. The propensity of any animal to behave violently, and in ways that may result in injury, harm or death to individuals riding on the animal, to individuals near the animal, and damage to property in the vicinity of the animal;
- ii. The unpredictability of an animal's reaction to such things as sounds, sudden movement and unfamiliar objects, individuals, persons or other animals nearby;
- iii. The animal's response to hazards such as surface and subsurface objects;
- iv. Collision with other animals, people and objects;
- v. The potential of other individuals to act in a manner that may cause or contribute to personal injury, or damage to property, such as failing to maintain control over an animal, or failing to act within the limits of that individual's ability;

I further acknowledge that such inherent risks, liabilities, dangers, hazards and conditions include temporary and permanent bodily injury to animals, participants, riders and to other individuals, which may result from Rodeo Activities, including but not limited to participation in competitions, schooling, training, grooming, riding and being near animals. I further acknowledge the risk of the occurrence of negligence, including, but not limited to, negligence on the part of Lakeland, negligence resulting from use of equipment or animals supplied by Lakeland or others, negligence resulting from the supply of such equipment or animals, negligence resulting from the actions of other participants or riders, other individuals, and representatives, employees, servants, agents or contractors or sub-contractors of Lakeland. I am aware of the existence of all such risks, dangers, hazards and conditions, and the occurrence of negligence is a likelihood that is inherent in Rodeo Activities. I freely accept, and fully assume liability for and on behalf of myself and on behalf of the Minor, if applicable, all such risks, liabilities, dangers, hazards, conditions and the likelihood of the occurrence of negligence, and the possibility of temporary or permanent personal injury, death and property damage, or loss resulting from any of the foregoing, to me or to the Minor, as the case may be.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT:

In consideration of any of Lakeland, Lakeland College Rodeo Club and Lakeland College Conference Services accepting me as a participant in Rodeo Activities, or accepting the Minor as a participant in Rodeo Activities, as the case may be, and, if applicable, in further consideration of Lakeland or other persons or individuals providing or supplying to me, or to the Minor, either animals or equipment for use in the Rodeo Activities, I hereby irrevocably agree on my own behalf, and on behalf of the Minor and the Minor's personal representatives, as the case may be, as follows:

1. I hereby irrevocably and absolutely release and discharge Lakeland from any and all lawsuits, liabilities, claims, demands, losses, damages, death, injury, costs or expense, present or future, existing or not, or which may accrue, that I or the Minor, if applicable, may suffer or may be entitled to make or advance, or that my personal representatives, next of kin or assigns, or those of the Minor, may suffer as a result of my participation, or the participation of the Minor, in Rodeo Activities, as the case may be, and which may arise, or which may be due to any cause or effect whatsoever, including, but not limited to, any negligence, breach of contract or breach of any statutory duty of care or other obligation whatsoever, arising from participation by me, or by the Minor, in Rodeo Activities;
2. I hereby irrevocably agree to hold harmless and indemnify Lakeland absolutely from any and all lawsuits, costs, expenses, damages and liabilities for any death, injury, loss, damage, cost or expense that I, or the Minor, if applicable, may suffer, or that any other person may incur or suffer, that may result from, or be a consequence of, participation by me, or by the Minor, as the case may be, in Rodeo Activities, and which may arise or which may be due to any cause or reason whatsoever, including, but not limited to, any negligence, breach of contract, or breach of any statutory duty of care by Lakeland;
3. If I am signing this agreement as a parent or guardian of a Minor, I hereby irrevocably agree to indemnify, absolutely, Lakeland from and against all lawsuits, liabilities, claims, demands, losses, damages, costs, expenses and other claims of any nature whatsoever that may hereafter be advanced or that may be entitled to be advanced on behalf of the Minor by any of the Minor's personal representatives or trustees, inclusive of all costs, expenses, legal fees and disbursements on a solicitor and own client basis, associated with both the defense, and any settlement or compromise, of any such lawsuits, liabilities, claims, demands, losses, damages, costs, expenses and other claims.
4. This Agreement shall be effective and binding on myself and upon the Minor, if applicable, and upon our respective heirs, next of kin, executors, administrators, assigns; and personal representatives and any trustees.

In entering into this Agreement I am not relying on any oral or written representations or any statements made by or on behalf of Lakeland or by any other person other than as set forth in this document, and this document records and forms the entire agreement.

I acknowledge that this document is a binding legal agreement and that I am entitled to have, and have had, the opportunity to obtain my own legal advice on the meaning and effect of this document before signing it.

I have read and understand this agreement. I am aware that by signing this agreement I am waiving all present and future legal rights which I, or my personal representatives, heirs, next of kin, executors, administrators and assigns may have or be entitled to make against Lakeland.

I further understand that as parent or guardian of the minor, if any, that on behalf of the minor I have waived all the minor's present and future legal rights and those of the minor's personal representatives, heirs, next of kin, executors, administrators, assigns and trustees, if any, to make claims against Lakeland. I further confirm that I have fully indemnified and will at all times, present and future, hold Lakeland harmless from any claims advanced by or on behalf of the minor.
